### Specifications for Videography, Photography and Live Streaming at the Heritage Careers Expo 2021

#### 1. Background:

Media, Information and Communication Technology Sector Education (“MICT SETA”) is a statutory body established through the Skills Development Act of 1998 to enable its stakeholders to advance the national and global position of the Advertising, Film and Electronic Media, Electronics, Information Technology and Telecommunications sectors in the Large, Medium, Small levy paying and non-levy paying companies in the sector.

#### Vision

A global leader in the development and delivery of revolutionary ICT skills.

#### Mission

We provide opportunities through funding of skills development for our stakeholders to participate in the economy, through meaningful employment and entrepreneurship, in building a capable, creative and innovative developmental state.

#### 2. Objective

The objective of this request is to appoint a competent service provider to provide Videography and Photography services for the Heritage Careers Expo which will be showcased on various digital platforms.

The closing ceremony will be preceded by the Fashion Friday event to take place at the College of Cape Town on 04 June 2021 which must be recorded into an edited 10-15-minute video.

The Heritage Careers Expo will act as a platform to showcase and celebrate the vast wealth of South African Heritage. This initiative is led by the Department of Higher Education, Science and Innovation, and endorsed by Honourable Deputy Minister, Buti Manamela in partnership with strategic partners in the Post Education and Training sector, SETA’s and the like.

The objective is to showcase, promote and influence youth to consider careers in the heritage sector and is celebrated under the theme “Unlocking the wealth within our Heritage”. It also aims to:

- Create awareness about the wealth within the Heritage Sector;
- Tell the story of heritage in higher education; and
- Expose learners to vast career opportunities that exist in the Arts, Culture and Heritage sectors
- Expose learners on how Science and Technology is a catalyst in conserving our indigenous languages, culture, cave art, oral history, maintenance of the ecosystem and reading of fossils etc; and

- Expose learners on how to capture history as it happens for future generation using today's technology devices.

The Heritage Careers Expo Video showcase seeks to profile careers in the heritage sector. It should creatively and innovatively deliver holistic insight into the various sectors of focus areas i.e. fashion, food, song dance, poetry and visual arts. The Heritage Careers Expo Video showcase content should focus on the Master Champion, sector, key role players/experts in the sector and showcase their experiences within their applicable work environments. Furthermore, the video showcase final product should act as a tool to promote careers in the heritage sector to prospective students, learners take up careers as poets, authors, artists, actors, designers and other occupations in the arts and cultures industry.

### **3. Scope of Work/Terms of Reference**

#### **3.1 Technical Specification:**

Service provider to provide all video production equipment, which includes but not limited to:

#### **Fashion Friday Video**

Date: 04 June 2021

A 10-15-minute edited video encapsulating the Fashion Friday event

Vox-pop of attendees, designers and models – minimum of 10 clips

A separate 5minute video capturing the behind-the-scenes and event set-up.

#### **Pre-event videos (closing ceremony):**

A 5-minute video summarising “**From Mapungubwe to Cape Point**” – the supplier will be supplied with the footage of the opening ceremony and other activations that took place during the month-long campaign.

3-minute behind-the-scenes video capturing the planning and set up of the event – featuring interviews with the team setting up the event.

#### **Closing event videos**

Date: 08 June 2021

Venue: College of Cape Town – Crawford Campus

The event will have three activation areas namely.

- Main Area
- SETA Villages
- Trojan Horse

1. The Services provider will produce a 10-15 video of the closing event including all activations of the day
2. A separate video for each activation area namely, main area, SETA village and Trojan Horse – 5-minute video
3. Social media clips - minimum of 30 social media clips for the event
4. Supplier to make provision for the external hard drive
5. All raw footage to be stored in the external hard drive and supplied back to the Department of Higher Education
6. X3 Crews are required for the project to ensure on-time delivery of the videos

7. X2 Photographers are required to capture all areas listed above. Photographers must be at all activations for pre-event activations as well as the closing event
8. Supplier to livestream the event on social media platforms (black magic device)
9. Film cutaways
10. Video lighting
11. Professional Sound recorders and lapel mics,
12. Editing and sound mixing software
13. Basic music library
14. Subtitles
15. Supplier to conduct voxpop interviews with the speakers and attendees which must be integrated into the final video.
16. Materials & tapes stock (raw footage and edited)

### **Outputs and Deliverables:**

The Service provider will be required to:

1. Develop the Heritage Careers Expo Video showcase overall concept and scenario as per specified objectives.
2. Interview selected interviewees for the video showcase who will include actual beneficiaries, Master champions/Industry experts in the various sectors (fashion, song and dance, poetry, food, visual arts) and other relevant key players in the post schooling education and training sector (Representatives from DHET, SETA's, Employers, Training Providers).
3. Visit the project sites (location shoots) to obtain links and cutaways.
4. Develop the video script and storyboard to be used in the video.
5. Present a draft video to MICT SETA for comments about contents.

### **Duration of the Assignment**

The total assignment duration is expected to take ten to twelve (10 -12) working days from the date of signing the contract/or receiving appointment letter.

### **Post Production**

Editing of video footage including addition of narration & music of raw footage for video production and post production and including multi-media manipulation

Translation & subtitling of media pieces where applicable

Finalisation of the video material (Colour & sound correction and any other graphical effects/additions needed) in the best format to be used online and another format for the use on other media outlets

Transferring video footage to DVD's for distribution to stakeholders including Artwork on discs and placement in plastic sleeves.

### **Experience in the requested services**

Preference will be given to professionals/companies that will be able to demonstrate prior experience of similar projects done. Experience should include but not limited to producing corporate videos, documentary films, ads, and 3 to 4 minute short format films, success stories/case studies etc. Proof of experience should be submitted with application to RFQ (samples/links of videography, documentaries, ads, corporate videos, product/service showcases etc).

The Service provider should be able to produce high quality, high definition and professional broadcast video on tight deadlines on a variety of different issues and subject matter.

To qualify, the company must have completed professional corporate work.

- 4.1 Brief storyboard proposal with shot compositions included, script, effective use of visual effects, graphics, audio, video transitions- all video clips fit story line and implementation of the assignment. ## EVALUATION CRITERIA

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
