## **DETAILED TECHNICAL SPECIFICATION**

### **APPOINTMENT OF A SERVICE PROVIDER TO CONDUCT VULNERABILITY ASSESSMENT**

#### **1. BACKGROUND**

The Media, Information and Communication Technologies Sector Education and Training Authority, the “MICT SETA”, was established in terms of the Skills Development Act, 1998 (Act No. 97 of 1998). It is responsible for skills development for its respective sub-sectors. The MICT sector is made up of five sub-sectors that are interconnected but also quite distinct and identifiable. These are Advertising, Film and Electronic Media, Electronics, Information Technology and Telecommunications.

#### **2. INTRODUCTION**

The MICT SETA is in the process of creating a digital organisation. As part of these plans, the MICT SETA plans to appoint a competent and experienced service provider to conduct a vulnerability assessment.

As a drive to achieve the above, the MICT SETA intends to improve its control environment, and proactively protect its information asset. The service provider is required to provide services that will assist the MICT SETA to identify cyber / security / ICT vulnerabilities that the organisation's ICT environment is exposed to and report on recommended remedies / mitigations to close the gaps. The MICT SETA is committed to implement the mitigation strategies / solutions to minimise and / or reduce its ICT vulnerabilities.

#### **3. PURPOSE**

The MICT SETA is looking for a competent and experienced service provider to conduct a comprehensive cyber / information security / ICT vulnerability assessment. Through this project, the MICT SETA aims to eliminate exposures to its data and information, increase confidentiality of data and information, system integrity and availability.

## **4. SCOPE OF WORK**

### *4.1. Technical Requirements*

#### **Service Specifications**

Utilising own Vulnerability Assessment tools, the service provider must fulfil the following requirements, *inter alia*:

- Scan and discover all devices connected to the network;
- Scan all mobile and Wi-Fi systems;
- Scan all services, computers connected to the network;
- Conduct application scanning;
- Assess all vulnerabilities to network nodes and devices; and
- Develop a user awareness questionnaire.

Any other function required for a comprehensive vulnerability assessment

#### **Deliverables**

The service provider must deliver the following:

- a) A detailed report and presentation on all discovered vulnerabilities.
- b) Ratings of identified vulnerabilities in terms of likelihood and impact.
- c) Remediation / mitigations for all identified vulnerabilities.
- d) Implementation Plan.
- e) A user awareness questionnaire.

### *4.2. Exclusions*

This is a full vulnerability assessment project which should include all scope required for the nature of these projects.

There are no exclusions to the scope. It is an assumption of the MICT SETA that the bidder possess the necessary skills set to deliver on the scope of this project. No exclusions of data in terms of best practice will be accepted in conducting this assignment.

### *4.3. Project Plan*

A project plan detailing all activities of this project with clearly articulated timelines is required when submitting the bid proposal.

### *4.4. Delivery*

It is expected that the MICT SETA will enter into a service level agreement (SLA) with the successful bidder for a period of assignment as determined by the bidder's project plan. This is a once-off service.

### 6.1. MANDATORY CRITERIA

6.1.1. Bidder must have 2 years' experience in rendering similar services in the past.

#### **Proof of compliance**

- The bidder must submit 2 or more contactable reference letters from different clients indicating vulnerability assessment rendered within the last 2 years or more, References letter /s should be on the client's letterhead, signed by a Company representative and include all of the following: vulnerability assessment rendered, Length of Contract, results achieved, and customer satisfaction. **(Letters that do not indicate all of the elements stated herein will be rendered Invalid reference)**

- c. If two or more tenderers have equal points, including equal preference points for B-BBEE, the successful tenderer must be the one scoring the highest score for functionality, if functionality is part of the evaluation process.
- d. In the event that two or more tenderers are equal in all respects, the award must be decided by the drawing of lots

### EVALAUTION ON 80/20 PREFERENCE POINT SYSTEM

- a. The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder
- b. Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- c. In the event that two or more bids have scored equal pints, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- d. However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality
- e. Should two or more bids be equal in all respect, the award shall be decided by the drawing of lots.

- b. Bidders other than EME's or QSE's must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by SANAS.
- c. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- d. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
- e. Tertiary institutions and public entities will be required to submit their B-BBEE status level certificates in terms of the specialized scorecard contained in the B-BBEE Codes of Good Practice.

## CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
