6.1.1. The Bidder must have conducted similar services of transcribing of recordings and report writing in the past two (2) years .

The bidder must provide two (2) contactable reference letters indicating similar transcribing of recording and report writing services in the past two (2) years on the client's letterhead, signed by authorized personnel.

Note: Bidders that do not meet the requirements of set mandatory criteria will be eliminated from further evaluation process.

6.2.
