# APPOINTMENT OF A COVID-19 MEDICAL PRACTITIONER SERVICES INCLUDING COVID-19 TESTS SERVICES FOR A PERIOD OF 12 MONTHS – 1 YEAR

#### 1. BACKGROUND

The Media, Information and Communication Technologies Sector Education and Training Authority, the "MICT SETA", was established in terms of the Skills Development Act, 1998 (Act No. 97 of 1998). Is responsible for skills development for its respective sub-sectors. The MICT sector is made up of five sub-sectors that are interconnected but also quite distinct and identifiable. These are Advertising, Film and Electronic Media, Electronics, Information Technology and Telecommunications.

MICT SETA seeks to appoint a qualified Covid-19 Medical Practitioner Services Including Covid-19 Tests Services for a Period of 12 Months – 1 Year.

#### 2. SCOPE OF WORK

## Qualifications, experience and skills

- **2.1** Registration with the Health Professional Council of South Africa (HPCSA).
- **2.2** Medical qualification MBChB (NQF Level 8).
- 2.3 National Diploma in Occupational Health (DOH) (NQF Level 8).
- **2.4** Occupational Health Practitioner for more than 12 months, minimum relevant experience 6 8 years occupational health experience of which 4 years must be in a management role.

## 3. DELIVERABLES

- 3.1 The medical Practitioner will be tasked with administering and supplying the COVID-19 tests, must provide medical report for each employee of initial diagnosis on medical condition.
- **3.2** Ensuring compliance with the statutory requirements; applying specific occupational medicine knowledge, Skills and techniques in order to determine whether an employee is medically fit to perform such job *is or is not COVID-19 Infected Conduct COVID-19 tests and medical assessment.*
- 3.3 Advise and recommend to management based on medical opinion to determine whether an employee is medically fit to perform and or should be quarantined according to set South African Disaster Management Regulation.

Must provide a comprehensive Curriculum Vitae (CV) with details of experience as an Occupational Health Practitioner.

- a. Bidders who qualify as EME's and QSE's in terms of the B-BBEE Act must submit a Sworn affidavit. Misrepresentation of information, constitutes a criminal offence.
- b. Bidders other than EME's or QSE's must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by SANAS.
- c. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
