EVALUATION CRITERIA

6.1. MANDATORY CRITERIA

RFQ's received will be evaluated against the following criteria:

- 6.1.1. The Bidder must have conducted / rendered similar services of transcribing of recordings and report writing in the past.
- 6.1.2 The Bidder must submit proof that such experience has been obtained over a minimum period of two years.

Proof of compliance

The bidder / service provider must provide two (2) contactable reference letters in the bidder / service provider's name indicating rendering of similar transcribing of recording and report writing services in the past on the client's letterhead, signed by authorized personnel.

Note: Bidders that do not meet the requirements of set mandatory criteria will be eliminated from further evaluation process.

- 6.2. RFQ submission that meet the mandatory will be further evaluated on Price and B-BBEE according to the 80/20 preference point system in terms of the PPPFA Regulations 2017, where 80 points will be for Price and 20 points will be for B-BBEE status level of contribution. *The duly sworn and commissioned BBBEE affidavits must be based on the Audited Financial Statements/Financial Statements and other information available on the most recent latest financial year- end DD/MM/YYYY. - c. If two or more tenderers have equal points, including equal preference points for B-BBEE, the successful tenderer must be the one scoring the highest score for functionality, if functionality is part of the evaluation process.
- d. In the event that two or more tenderers are equal in all respects, the award must be decided by the drawing of lots

EVALAUTION ON 80/20 PREFERENCE POINT SYSTEM

- a. The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder
- b. Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- c. In the event that two or more bids have scored equal pints, the successful bid must be the one scoring the highest number of preference points for B-BBEE.
- d. However, when functionality is part of the evaluation process and two or more bids have scored equal points for B-BBEE, the successful bid must be the one scoring the highest score for functionality

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
