- 6.1.1. The Bidder must have conducted / rendered similar services of transcribing of recordings and report writing in the past.
- 6.1.2 The Bidder must submit proof that such experience has been obtained over a minimum period of two years.

Proof of compliance

The bidder / service provider must provide two (2) contactable reference letters in the bidder / service provider's name indicating rendering of similar transcribing of recording and report writing services in the past on the client's letterhead, signed by authorized personnel.

Note: Bidders that do not meet the requirements of set mandatory criteria will be eliminated from further evaluation process.

6.2. RFQ submission that meet the mandatory will be further evaluated on Price and B-BBEE according to the 80/20 preference point system in terms of the PPPFA Regulations 2017, where 80 points will be for Price and 20 points will be for B-BBEE status level of contribution.
