### **DETAILED TECHNICAL SPECIFICATION**

#### **APPOINTMENT OF A SERVICE PROVIDER FOR THE ACQUISITION FOR A VIRTUAL SITE VISIT SOLUTION**

##### **1. BACKGROUND**

The Media, Information and Communication Technologies Sector Education and Training Authority, the "MICT SETA", was established in terms of the Skills Development Act, 1998 (Act No. 97 of 1998). It is responsible for skills development for its respective sub-sectors. The MICT sector is made up of five sub-sectors that are interconnected but also quite distinct and identifiable. These are Advertising, Film and Electronic Media, Electronics, Information Technology and Telecommunications.

The COVID-19 pandemic has disrupted the entire world and introduced what is termed "a new normal". The MICT SETA, just like any other organisation in the world was totally disrupted in its business processes. One of the MICT SETA business processes is to conduct physical site visitations to service provider's premises to do inspections. The Covid 19 restrictions have changed how the organisation does business, including the site visits. This then necessitates for a virtual model of conducting the site visits.

The organisation has trialled Blitzz solution to conduct virtual site visits. This solution is deemed to be fit for purpose.

##### **Purpose**

To invite prospective service providers to submit a proposal for the provisioning of a virtual site visit solution. The solution must cater for 600 credits for a period of 12 months.

##### **Objectives**

The objectives of the implementation of the Virtual Site Visit application:

- To ensure that part of MICT SETA's digital transformation drive is achieved.
- To mitigate the risk of exposure to Covid 19.
- To reduce travel associated costs with instant remote video assistance.
- To increase productivity by eliminating amount of time spent on the road for site visitations.

## EVALUATION CRITERIA

### 6.1 EVALUATION CRITERIA

RFQ's received will be evaluated against the following criteria:

1. PRE-QUALIFICATION CRITERIA (Regulation 4)-PPPFA

Bidder shall have a minimum B-BBEE status of level 2 or better.

#### **Proof of compliance**

Bidder must submit a valid proof of BBBEE status (BBBEE verification certificate issued by a SANAS accredited verification agency or CIPC B-BBEE certificate or B-BBEE affidavit duly sworn and commissioned).

Bidders please take note: The duly sworn and commissioned BBBEE affidavits must be based on the Audited Financial Statements/Financial Statements and other information available on the latest financial year- end DD/MM/YYYY. e.g 28 February 2021. (Kindly contact the BBBEE commission or the DTI for more information with regards to latest financial year end).

2. RFQ submissions must comply with the requirements of the detailed specification.

**RFQ submission that meet the Specification and Pre- qualification will be further evaluated on Price and B-BBEE according to the 80/20 preference point system in terms of the PPPFA Regulations 2017, where 80 points will be for Price and 20 points will be for B-BBEE status level of contribution.**

**CERTIFICATE OF INDEPENDENT BID DETERMINATION**

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
