> The SETA's responsibility in respect of service delivery

The PFMA and financial management

The Sector and/or the Constituency represented by the Member

> The strategic leadership role of the Accounting Authority

Education, training, skills development and human resource development

Quality assurance of learning provision

General management and business skills

> The communication and marketing role of an entity in relation to its stakeholders.
