DETAILED SPECIFICATION

APPOINTMENT OF A SERVICE PROVIDER FOR THE PROVISION, SUPPLY, AND CONFIGURATIONS OF LOCAL AREA NETWORK (LAN) FOR EAST LONDON REGIONAL OFFICE.

1. BACKGROUND

Media, Information and Communication Technology Sector Education ("MICT SETA") is a statutory body established through the Skills Development Act of 1998 to enable its stakeholders to advance the national and global position of the Advertising, Electronic Media and Film, Electronics, Information Technology and Telecommunications sectors in the Large, Medium, Small levy paying and non-levy paying companies in the sector.

This was because of Government's commitment to promote active labour markets policies and is demonstrated in the Skills Development Act of 1998 and the Skills Development Levies Act of 1999. As guided by its mandate, MICT SETA is as such, an agent of transformation by promoting employment equity and B-BBEE through skills development. In this context, MICT SETA is keen to form sustainable partnerships that will further promote its support for transformation.

The Media, Information and Communication Technologies Sector Education and Training Authority (MICT SETA) is a public entity established in terms of Section 9(1) of the Skills Development Act (Act No. 97 of 1998). The MICT SETA plays a pivotal role in achieving South Africa's skills development and economic growth within the 5 distinct sub-sectors it operates in, i.e. Advertising, Film and Electronic Media, Electronics, Information Technology, and Telecommunications.

The MICT SETA intends to modernise its value chain by introducing technology solutions that improve management and processing of its data and information in an efficient and effective manner, provide instant and accurate reporting and reduce manual processes in its value chain. The lack of adequate infrastructure has a negative effect on the organisation's ability to provide specific focused services in line with its value on customer centricity.

In line with the vision of the MICT SETA of "cutting-edge future skills", the MICT SETA ensures that all its offices are equipped with adequate ICT infrastructure to fulfil the customer centricity value. Accordingly, a need has arisen for the installation of ICT networking tools in the newly established East London Regional Office to enable the office to function, enable accessibility of the MICT SETA and improve communication with its stakeholders.

The MICT SETA is looking to appoint a suitably qualified, experienced, and accredited service provider for the provision, supply, and configurations of a Local Area Network (LAN) for its East London Regional Office.

2. PROJECT SCOPE

5. INSTALLATION

- a. It is expected that this specification will allow the Service Provider to scope and implement a complete and working Local Area Network solution. Should there be unclear or incomprehensive requirement; the bidder can seek further clarity at the Compulsory Briefing Session.
- b. All new installations are to be accompanied by a KRONE or Molex Certificate as well as a Visio Diagram indicating Network Point location in relation to office layout before the site installation can be signed off.
- c. The successful service provider will be required to ensure that all cabling and network points are clearly marked and labelled
- d. All required cables, software and accessories that make up the proposed solution must be included as part of the proposal.
- e. All cabling must be done neat to ensure a safe and clean environment. No cables are to be present on the floor nor must they be found to be easily snagged or pulled.
- f. The successful service provider will be required carry out all installations, documentation, and handover to MICT SETA network engineer.
- g. The devices in the rack must be connected and powered through the UPS.
- h. New network points must be commissioned in 3 offices, boardroom, reception area, and for an Access Point.
- i. Normal power points must be commissioned in the printing area and waiting area.
- All network points commissioned as part of the project must be tested for functionality.

6. MAINTENANCE, SUPPORT AND GUARANTEES (MANDATORY FOR SUPPLIED EQUIPMENT AND MATERIALS)

- a. The Service Provider is obliged to, as part of procuring the equipment, procure such in MICT SETA's name, with the necessary Support and Maintenance. The Service Provider may not provide maintenance or support for the said equipment.
- b. The Service Provider will be required to, as part of the deployment procured through this Acquisition Exercise, provide warranties for the workmanship, where the service provider will be required to remedy any identified poor workmanship at no cost to MICT SETA within 12 months after the installation.

7. COSTING MODEL

- a. The solution objectives together with scope of work should be considered when compiling the pricing for the delivery of the services.
- **b.** All costing must be projected inclusive of any applicable taxes. These costs should consider unit costs and hourly rates.
- c. Costing must be done inclusive of any applicable travel or allowances of any kind and should therefore be inclusive of all foreseeable costs to achieve the project objectives.

8. EVALUATION CRITERIA

The MICT SETA complies with the provisions of the Public Finance Management Act, Act No 1 of 1999 as amended; Treasury Regulations of 2005; the Preferential Procurement Policy Framework Act, Act No 5 of 2000; and the Preferential Procurement Regulations of 2017; and the MICT SETA Supply Chain Management (SCM) Policy.

Bids received will be evaluated against the following set evaluation criteria.

STAGE 1: MANDATORY CRITERIA

a) The Bidders must have undertaken and completed a minimum of three (3) ICT projects in the last five (5) years. Bidders must provide a minimum of three (3)

contactable reference letters related to bidders' experience in supplying and installation of networking services and equipment within the last three (3) years.

b) The bidders must be krone or Molex certified. A CommScope (Krone) or Molex certification of good standing must be submitted as part of the bid.

STAGE 2: PRICE AND PREFERENCE EVALUATION

Bidder must submit a valid proof of BBBEE contributor status (B-BBEE verification certificate issued by a SANAS accredited verification agency or CIPC B-BBEE certificate or B-BBEE affidavit duly sworn and commissioned) for points allocation.

8.1 PREFERENCE POINT SYSTEM

- a. The bidder obtaining the highest number of total points will be awarded the contract unless objective criteria justify the award to another bidder.
- b. In the event that two or more tenderers have scored equal total points, the successful tenderer must be the one that scored the highest points for B-BBEE.
- c. If two or more tenderers have equal points, including equal preference points for B-BBEE, the successful tenderer must be the one scoring the highest score for functionality, if functionality is part of the evaluation process.
- d. In the event that two or more tenderers are equal in all respects, the award must be decided by the drawing of lots.

8.2 POINTS AWARDED FOR PRICE

Maximum 80 points for price will be allocated as per paragraph 3.1 of Preferential Procurement Regulations 2011, refer to Preferential Procurement Claim form on **SBD 6.1**.

8.3 POINTS AWARDED FOR B-BBEE

Maximum 20 points for B-BBEE will be allocated as per paragraph 4.1 of Preferential Procurement Regulations 2011, refer to Preferential Procurement Claim form on **SBD 6.1**.

- a. Bidders who qualify as EME's and QSE's in terms of the B-BBEE Act must submit a Sworn affidavit. Misrepresentation of information constitutes a criminal offence.
- b. Bidders other than EME's or QSE's must submit their original and valid B-BBEE status level verification certificate or a certified copy thereof, substantiating their B-BBEE rating issued by SANAS.
- c. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- d. A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate bid.
