TERMS OF REFERENCE

1. INTRODUCTION

The Media, Information and Communication Technologies Sector Education and Training Authority (MICT SETA) is a public entity established in terms of Section 9(1) of the Skills Development Act (Act No. 97 of 1998). The MICT SETA plays a pivotal role in achieving South Africa's skills development and economic growth within the 5 distinct sub-sectors it operates in, i.e., Advertising, Film and Electronic Media, Electronics, Information Technology, and Telecommunications.

2. SCOPE AND REQUIREMENTS

2.1 Overview

The MICT SETA is looking to collaborate with suitable talent management provider/s to provide an industry professional/brand expert to launch a brand internalisation programme through delivery of a workshop. The brand internalisation programme will endeavour to help improve internal stakeholder satisfaction, increase brand loyalty by internal stakeholders, inspire brand ambassadors and ultimately drive organisational performance from a common denominator perspective.

The professional/brand expert must be an advocate for brands with extensive knowledge in brand management and marketing, with a proven track record of collaborating with organisations in building successful brands.
