## 7. EVALUATION CRITERIA

### 7.1 MANDATORY CRITERIA

**Criterion (a):** Bidder must comply with detailed specifications/requirements outlined on page 4 of this document.

**Criterion (b):** Bidder must provide two (02) samples of previous work completed of designing of certificates.

Bidders must submit two (02) hard copy samples of certificates previously designed. The provided certificates must comply with the scope of work outlined in clause 4.

**Criterion (c):** Bidder must have experience in designing and printing of certificates.

Bidder must provide two (02) contactable reference letters from different clients indicating bidders' experience in designing and printing of certificates. Contactable references letters must be in a client's letterhead, include name of company and contact details, dated and signed by the company representative. **Reference letters must be aligned to the previously designed certificates provided.**

#### 1.2 To be completed by the organ of state

- b) the **80/20 preference point system** will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is

adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2 DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
