REQUIREMENT DESCRIPTION: APPOINTMENT OF A SERVICE PROVIDER TO FACILITATE THE ETQA STRATEGIC PLANNING SESSION

1. INTRODUCTION

The Media, Information and Communication Technologies Sector Education and Training Authority ("MICT SETA") is established in terms of section 9(1) of the Skills Development Act, 1998 (Act No. 97 of 1998), and is responsible for achieving South Africa's skills development and economic growth within the following five sub-sectors: advertising, film and electronic media, electronics, information technology and telecommunications.

2. PURPOSE

The purpose of this RFQ is to invite service providers to submit quotations for facilitating a strategic planning session aimed at reviewing and aligning the ETQA's processes and objectives with MICT SETA's strategic goals and craft a roadmap for the **seamless integration of the transitional arrangements and its subsequent processes**.

3. SCOPE OF WORK

The appointed service provider will be expected to:

- Facilitate a two-day physical strategic planning session with ETQA Management and staff. And a follow-up online session to present the recommendations to the ETQA.
- Assist in identifying key performance areas, goals, and strategic initiatives for the ETQA department, aligned to the transitional arrangements.
- Craft a roadmap for the seamless integration of the transitional arrangements and its subsequent processes.
- Document Standard Operating Procedures linked to the transitional arrangements for adoption by the ETQA and MICT SETA as a whole.
- Guide the development of an action plan to enhance efficiency and improve quality assurance processes.
- Provide a detailed report summarizing the outcomes of the strategic session and recommendations for follow-up actions.

3.1. The key deliverables in respect of this scope includes:

- A well-structured facilitation plan tailored to MICT SETA's ETQA needs.
- Comprehensive facilitation of the strategic planning session.
- A detailed post-session report outlining key outcomes, strategic goals, and action items.

6. EVALUATION CRITERIA

MICT SETA complies with the provisions of the Public Finance Management Act, Act No. 1 of 1999 as amended; Treasury Regulations of 2005; the Preferential Procurement Policy Framework Act, Act No. 5 of 2000; Preferential Procurement Regulations of 2022; and the MICT SETA Supply Chain Management (SCM) Policy.

RFQs received will be evaluated on mandatory evaluation criteria, price and specific goals comparison.

6.1 STAGE 1: MANDATORY CRITERIA

a) Experience of the Facilitator:

- Have a proven track record of facilitating strategic planning sessions, preferably within the education and training or SETA environment (minimum of 2 years' experience).
- Have excellent facilitation skills and the ability to engage with diverse groups of stakeholders.

Proof of Evidence to criterion (a):

- The bidder must submit a detailed CV of the Facilitator that clearly articulates no less than two (02) years' experience in the facilitation of strategic planning sessions.
- Submit a close-out report for a similar scope of work which includes feedback from the client.

b) Experience of the Bidder

Bidder must have experience in the facilitation of strategic planning in a SETA environment.

Proof of Evidence to criterion (b):

Bidders must provide two (02) signed contactable reference letters from different companies for the facilitation of strategic planning workshops from clients.

Reference letters must be on the client's letterhead, signed by company representative of the bidder's client. Contactable reference letters must include name of company, contact details and project description.

Note: Bidders that do not meet the set mandatory evaluation criteria will be eliminated from further evaluation process.

6.2. PRICE AND SPECIFIC GOALS
